Note : * The approval for increase in intake/additional course (s)/variation in intake is valid for two year from the date of issue of this letter for obtaining affiliation with concerned university and fulfilling concerned state govt. requirements for admission.

That the institution shall have appropriate a sequence of Supreme Court of India in Writ Petition vis. (c) 050/1998. Increase of failure to prevent the instances of ragging by the Institutions, the Council shall take appropriate action including withdrawal of approval".

The additional intake is being granted based on the projections shown in the Detailed Project Report regarding additional built up space, faculty and other facilities for the proposed intake. It may be noted that all the facilities including additional built up area should be made available and appointment of faculty should be made available before the commencement of the next academic session. Random surprise inspection would be carried out to verify facilities and if the institute is found deficient in fulfillment of norms & standards of AICTE, appropriate action would be initiated by the Council.

Please note that other terms & conditions in the earligr letter of even no dated 28.05.2008 will remain unchanged.

This approval is granted based on the Appraisal of the information by the institution on infrastructural facility and academic facilities created for the proposed course (s). Therefore the approval is subject to the verification of the claims made by the institution through an Expert Committee visit. In case the claims made by institution are found to be false, the approval granted shall be liable to be withdrawn.
